

Terms and Conditions Participants

X Diving



Article 1: Definitions

1.1. In these Terms and Conditions is understood:

- a. Event: The activity organised by the Royal Dutch Swimming Federation in cooperation with Indoor Cliff Diving.
- b. Participant: The natural person who entered the Event according to the conditions of the Organiser.
- c. Mentor: The natural person appointed by the Participant, to accompany the Participant during the Event.
- d. Agreement: Agreement between Participant and Organiser
- e. Organiser: Legal Person (local organisation / competition management who organise the Event) by which the Participant entered into an agreement.
- f. KNZB; Royal Dutch Swimming Federation.

1.2. These terms and conditions apply for every Agreement.

Article 2: Participation

2.1. The Participant may participate if he will meet the requirements, set by the Organisation, on the day of the Event.

2.1.1. The requirements:

- a. The Participant is an adult (age of 18) on the day of the Event.
- b. When the Participant is a minor (at least 16 years), permission will be asked to the parent and can only participate with permission of the Organisation.
- c. The Participant is required to have at least one mentor. This may be another Participant. Mentors may accompany more Participants on the same time.
- d. The main task of the mentor will be to take care of the Participant in case of injuries and accidents.
- e. If the Participant doesn't have a mentor, the Participant is not allowed to participate in the Event.

2.2. The Participant can only participate if he has signed an entry and waiver form and agreed on the terms and conditions for the Event.

2.3. The Organisation can exclude a Participant of participation to guarantee the safety and order.

2.4. When the Participant is prevented to participate in the Event, the Organiser will determine whether the entry fee will be refunded.

2.5. The Organiser can cancel the Event any time due to force majeure.

Article 3: Personal Data

On the webpage www.knzb.nl some privacy data will be processed. The KNZB considers careful handling very important. The KNZB will carefully process and secure the data.

While processing your data, we will adhere to the requirements of the General Data Protection Regulation. This means among other things, we:
